01 Reportability and Risk Management

Objetive:

Ensure regulatory compliance under rigorous integrity standards, anticipating and mitigating risks and reporting on our performance..

Targets:

- Continuously update the risk matrix and associated controls, incorporating ESG criteria.
- Maintain our yearly standing on the Dow Jones Sustainability Index (DJSI).

Actions:

- a. Ensure regulatory compliance under rigorous integrity standards, anticipating and mitigating risks.
- b. Report on our performance per SASB® and Financial Market Commission (CMF) standards.
- c. We participate annually in the DJSI index.
- d. We have a robust structure of procedures, policies and manuals accessible by all employees in our internal management system.

- g. We conduct independent external audits, demonstrating our commitment to transparency and accountability.

Foster and diversify our team's talent, focusing on the highest safety standards, contributing to the wellbeing of the community and our environment through strategic alliances.


Targets:

- 100% of onboard personnel trained in the SAAM Towage curriculum.
- 35% of open positions filled by internal candidates each year.
- 100% mixed short lists in selection processes.
- 0% accidents with serious injury or fatality (SIF).

Actions:

- We promote occupational health and safety as a core, organization-wide value for all our employees through the +Safety Training Program.
- b. We encourage continuing education with a training and development program to build skills and competencies.
- c. We promote an inclusive, diverse work environment, fostering each individual's development in a climate of respect and nondiscrimination.

- d. We have several agreements for employees to use sports facilities.
- e. We have various corporate governance tools, policies and procedures in place to ensure human rights are respected. We adhere to and respect the Ten Principles of the United Nations Development Program (UNDP).



03 Environment and Climate Action

Objetive:

Implement measures that help mitigate climate change and achieve carbon neutrality and adopt a standardized management system to optimize our environmental performance.

Targets:

- Neutralize 65% of our Scope 1 and 2 emissions through reduction and offset initiatives (2021 baseline).
- Certify 100% of our operations under PAS 2060 and/ or ISO 14001 quality and environmental management standards.

Related SDGs



Actions:

- a. We drew up an action plan for ISO 14001 and PAS 2060 certification.
- We have a Waste Management program with action plans to reduce waste, train employees in this area and invest in innovation or R&D for environmental management.
- c. We carry out a control and inventory of Scope 1 and 2 greenhouse gas (GHG) emissions certified by accredited verification agencies.
- d. We analyze and adopt systemic measures, new technologies and projects to reduce and neutralize greenhouse gas emissions and share results with clients to support reduction on their Scope 3 emissions.



Two electric tugs are already operating in Canada in partnership with Teck and Neptune. A third, the result of an alliance with ENAP, will soon be operating in Chile.

04 Sustainable Development and Projects

Objetive:

Implement innovative projects to enhance our operations, aligned with our commitment to develop comprehensive solutions that meet our customers' needs.

Targets:

- 10% of tugboats with more sustainable propulsion, compared to 2021 baseline.
- 100% of new contracts with sustainability clauses.

Actions:

- a. We research and develop integrated solutions to enhance our operations.
- b. We are constantly developing more sustainable technologies.
- c. We investigate the availability of alternative fuels for different operations.
- d. We collaborate with universities for knowledge and technology transfer and promote efforts to attract and train talent.
- e. We develop strategic alliances with suppliers to promote technologies to optimize asset management.
